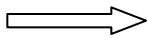

**The Whyte Museum reserves the right to refuse to supply reproductions and/or permit use based on any of these factors.**

1. Reproductions are for a **ONE** time use only and cannot be reproduced, scanned, transmitted, sold, loaned, exhibited, deposited in another repository or used for any other purpose unless prior approval is received. See *Use of Reproductions and Use Fees* schedule for detail.
